## **Dangerous Cargo shipment terms:**

Shipment shall be subjected to approval of the Slot Provider, vessel's owners, master and P&I.



The Slot User must ensure that all dangerous cargoes are stowed, packed, properly labelled, etc, in accordance with the IMDG Code Rule Book. In addition, containers carrying such IMDG cargoes must be sufficiently marked and labelled with the correct signs.

The Slot User shall indemnify the Slot Provider and/or its agents against any claims for damages/losses howsoever caused – including but not limited to any non-declaration, incorrect or misdeclaration of dangerous cargo – arising from the shipment of dangerous cargo.

# DANGEROUS CARGO RESTRICTION LIST GENERAL EXCLUSION:

- 1. All commodities covered under Special Provision 76,900,349 to 353 of the IMDG code.
- 2. Any commodity containing Calcium Hypochlorite.
- 3. All Toxic Waste /Saap covered by the Basel Convention.
- 4. IMDG regulated cargo in a Reefer container when there is a subsidiary explosive risk.
- 5. IMDG regulated cargo in Flexibag / Flexitank.
- 6. IMDG regulated cargo packaged in Bulk Packing.

Apart from the above general exclusions the following specific commodities are either Excluded/Restricted for carriage.

Excluded: E-Excluded for general carriage. Exceptions on a case-by-case basis with Special Approval.

Restricted: R-Acceptable for carriage provided specific requirements of Owners, POL/POD are fulfilled.

#### **CLASS 1 - EXPLOSIVES**

All Military cargo is strictly subject to a case-by-case approval for class, subdivision, documentation, licenses, POL/POD permission, and Vessel Owner's approval. Sufficient lead time must be available to verify the necessary steps
